They require working smoke and carbon monoxide (CO) alarms in all private rented property in England.

Landlords could be fined up to £5000 per property for failing to comply.

What to do in case of fire in your home



1. Feel the doors to see if they are hot. If they are, do not open them - use an alternative escape route

3. Stay close to the

2. Keep doors and windows closed.

4. Get out of the house as quickly as possible. Follow a planned escape route



5. Call the fire service on 999 as soon as possible from outside your house

What is Carbon Monoxide?

Carbon monoxide (CO) is an extremely dangerous colourless, odourless and tasteless gas produced when a fuel is not burnt properly. The most common sources of CO are faulty boilers, gas fires and cookers. The only way to detect this silent killer is by fitting an audible CO alarm.

What to do in the event of a CO alarm activating



1. Keep calm and open the doors and windows to ventilate the property



2. Stop using all fuel burning appliances and if possible, turn them off



3. Evacuate the property leaving the doors and windows open



4. Ring your fuel supplier on their emergency number; keep the number in a prominent place. do not enter the property until it has been declared safe.



5. Get medical help immediately for anyone suffering the effects of carbon monoxide poisoning (headache, nausea, drowsiness)
